The **Crescent Lake Association Annual Meeting** will be held at the **Unity Fire Station** the first Saturday after the 4th of July. This year that means the meeting will be held **July 8, 2006**, from 10:00 a.m. until noon.

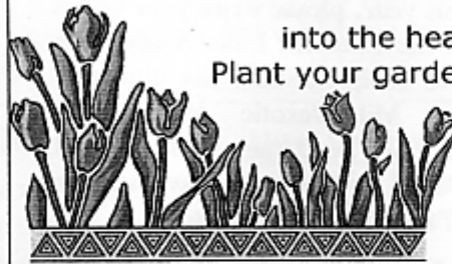
At the 2003 Annual Meeting the CLA cottage owners voted to raise the annual dues to \$40.00 per cottage owner. Members voted to apply \$30.00 to support the **Milfoil Committee's** work, so of the \$40.00 dues, \$10.00 goes to the operation of the CLA, and the rest goes to combat Milfoil.

The Milfoil Committee's programs will cost an estimated \$11,500 each year from now on. For this year that budget will be financed as follows: **State of NH**, \$3,000; **Town of Acworth**, \$2,000; **Town of Unity**, \$1,000; **Crescent Lake Association Dues**, \$4,500; **Donations**, \$1,000.

The Milfoil Committee's work is like an **INSURANCE POLICY** on your cottage valuation, helping to protect our most important resource. Where else can you get an insurance policy for \$30.00 to help preserve your property value? The answer is, "**YOU CAN'T.**" So support the eight cottage owners who work 365 days a year to help keep our lake free of invasive weeds. Where else can you get fireworks, canoe races, golf tournaments, annual picnics, and a clean

and informing boaters about the danger of carrying weeds from one body of water to another. The committee has again put in place a program to perform a lake bottom weed survey as well as boater surveys and boat/trailer inspections throughout the summer.

dog?

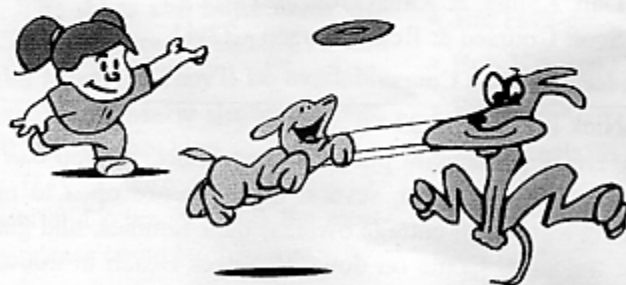
Dogs are great fun at times,

CLOSING WEEKEND, OCTOBER 2005: We have been closing our cottage now for 22 years here at Crescent Lake and have had some interesting weather to cope with over the years including snow and 90 degree weather but this one took the cake.

We got here Friday the 7th to enjoy what we thought would be a peaceful, fun weekend. Our neighbor, and now my sister-in-law Mary Hanners Grenier and a few of their friends would be up to play golf all weekend and just hang out. Well, the rains started and never stopped. Needless to say, golf was out and card games were in. After a nice dinner at the Shutters Saturday night and more card games at Mary and Paul's, we crossed the street to find our place flooded from the rains off the mountain and the overflow of the brook. Thinking we were funny, we put on life jackets and sang "Nearer My God to Thee," never knowing what we would encounter the next morning. Early that morning the news was horrible and the scene on the lake wasn't much better. Mike and Jane Maines' property was so bad...Mike woke up to the sounds of raging water on one side of his camp and the lake coming up the front. He said it was a little unsettling to say the least. Our place looked like we lived on a house boat.

Thankfully, David, Tim and Bob helped our guys remove the docks and Tom's paddleboat from the dam. The roaring waterfall was the most incredible sight and the raging water flowing under the bridge is a sight we'll never forget.

Closing is always sad but this year it was terrible because of all the heartaches in Alstead, Acworth, and other towns in New Hampshire.

We hope for a more tranquil winter and can't wait to see our beautiful Crescent Lake again in April.

Favorite Places: The Back Side Inn

Since then it's been non-stop activity as the pair worked to renovate the guest rooms and public spaces while retaining the Inn's existing clientele and attracting new customers for Anne's vast culinary talents as executive chef.

With extensive experience at top-rated restaurants in the Hamptons (Long Island), in California, at Mont Tremblant in Quebec and at western ski resorts, Anne offers her guests and diners a touch of the true four- and five-star experience when they come to table, as she told a reporter for the *Argus-Champion* last summer.

And she succeeds. "This is no hamburger joint," wrote Allen Lesels in *New England Magazine*.

A typical fixed price winter menu (at under \$25 last winter) includes a choice of tasty starters, plus soup or salad and entrees such as Chef Anne's chicken picatta, traditional chicken marsala, shrimp scampi over handmade linguini,

fresh haddock fillets with crabmeat hollandaise, sirloin strip steak in an herb butter crust or smothered with mushrooms and onions, cranberry maple glazed pork tenderloin medallions in an orange cognac sauce topped with prosciutto and caramelized onions, or sliced boneless duck breast--each dish generously garnished with delicious veggies and a starch. And of course there's dessert--a tempting array of Anne's own pastries and other delights.

To enjoy the bounty of Sunday brunch, you might want to skip dinner the night before just to save room for tasting everything! The Wednesday evening handmade pasta buffet has already become a hit with locals and visitors alike.

The Back Side Inn, on the back side of Mt. Sunapee at 1171 Brook Road, Goshen, is a BYOB establishment, and you can call ahead to ask for special menus--in fact, Anne does a large portion of her business by request and reservation. Call 863-5161 or visit www.backsideinn.net

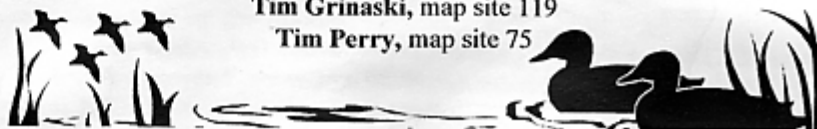

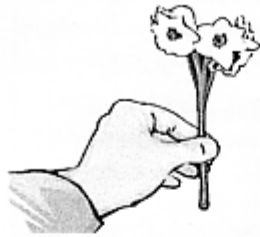

In a spontaneous display of generosity during last year's Labor Day picnic, several people started circulating through the crowd with brown paper bags for donations to support the Hurricane Katrina relief effort. (We know certain people spearheaded the effort, but we've lost the list! Thank you all anyway.)

Entirely separate from the other fundraising efforts of the day, the brown bag collection took in \$1500, an already impressive amount which one anonymous donor then decided to double with matching funds. Later that month, Fred Yates

delivered our \$3000 donation in a brown paper bag to American Red Cross representative Karen Fabis, at her office in Keene.

Speaking for the Red Cross to the Crescent Lake Association, Karen said, "Because of your generosity, the many victims of this year's devastating hurricane will have the chance to recover and move forward." Also, "Our highest priority will always be to those facing challenges from natural or man-made disasters. Your help makes our lives a little easier. Thank you for your support of the lifesaving mission of the Red Cross."

Little did she know at the time that the Red Cross and other agencies would need to help people from our area after the flooding just a month later, and again in May of 2006.

Acworth residents, to speed response time in case of medical emergency, DO NOT call 911. The 911 system calls an ambulance from Bellows Falls for emergencies in Acworth. Average time to reach the lake is 18-19 minutes, and could be longer now that part of Unity Stage Road is out.

Instead, call **Golden Cross Ambulance** at (603) 542-2244. Golden Cross will come from Claremont and can make it to the lake in about 7 minutes.
